## APPLICATION FOR USE OF SPLASH PARK

Rentals will be available Monday – Friday from 5:30-7:30 pm and Saturday - Sunday from 3:00 – 5:00 pm. The rental includes use of the Splash Park, picnic shelter closest to the splash park (East shelter) beginning at 5:15 pm Monday- Friday and 2:45 pm Saturday - Sunday. This includes the renter’s set-up and clean up time.

The rental fee is \$175 for RESIDENTS and \$225 for NON-RESIDENTS. A \$175 Security Deposit is also required. **A CANCELLATION FEE OF \$25.00 WILL BE CHARGED. IN THE EVENT OF RAIN, THE PARTY MAY BE MOVED TO ANOTHER AVAILABLE DATE OR A FULL REFUND WILL BE GIVEN. THE RENTER IS RESPONSIBLE FOR CONTACTING THE PARK DISTRICT IN THE EVENT OF A CANCELLATION WITHIN 24 HOURS OF THE EVENT TO RECEIVE A FULL REFUND LESS THE \$25 CANCELLATION FEE.**
