I. Facility Update

A. Founders Center – Gym Ceiling – The Boards packets contained information on expenses thus far for the gym. The truss was stabilized, and the engineers will check it to provide documentation to the Village. Additional failing of the webbing of the next truss was observed by the engineers. Gina has contacted a wood truss company for advice. PDRMA has been notified for possible reimbursement. Appraisal of the Founders Center was suggested to see if it would be worth it to repair. Staff has reached out to schools and the library to help relocate programs. It was suggested to do a press release once the expenses and work is determined. Discussion was held.

- i. Five Oaks No liens exist on the deed/title for the park parcel. The Forest Preserve District does not have plans to develop their adjacent property.

- A. Lincoln Meadows Staff is waiting on the grant agreement for the Warriors Course.
- B. Windy Hill Park OSLAD Bids went out this week for proposals for the playground equipment.
- C. Splash Pad DCEO Staff submitted the paperwork and noted that the work was done. Hopefully funds will be received soon.
- D. Will County ARPA –HVAC project Staff received the paperwork for the grant.
- E. OSLAD Opportunities The State has released the OSLAD Grant that will be due in July. The next park to revitalize is Timbers Edge. Discussion was held regarding if it was financially worth it to apply for a grant that might not qualify or to update the park without incurring the costs of applying for a grant.

 - IX. Employee Compensation Review A salary and wage survey were included in the packets for the hourly employees in the Building and Grounds department. It was conducted by IPRA and Gina also used another survey by a south suburban group. Gina used the data to show the commissioners where the wages offered come in under average. There would be a \$30,000 impact to the budget to get the wages up to the average. Discussion was held.

 - A. Warriors This group was originally an FPD program. Gina gave an overview of how they became an affiliate organization. They do not use FPD facilities like other affiliate groups do. FPD arranges their games and practices with the schools and the Warriors pay based on FPD rates. Warriors is not a Recreation Program run by FPD. Concerns are if we cut them loose, then the District is in competition with them for use of the schools gyms. Discussion was held. Gina will reach out to the Warriors to start the conversation to have them disassociate the organization with FPD.
