- III. Facility & Property Update
 - A. Indoor Recreation Center
 - Survey Discussion A copy of the summary was part of the Board's packets. There is no support for the two top designs. To sell the property it has to go to referendum. Discussion of to keep asking for an increase was held. Most responses were to not raise taxes. The survey brought up using Lincolnway North which is not an option. The traffic of the Patriot Center was discussed. A Bond Referendum needs a project tied to it. FPD needs \$1 million minimum for operating cost ongoing. Discussion of the tax base and need for operating budget was held. The immediate concern and needs is the Founders Center. Selling the property was discussed. Cost of doing a Referendum is approximately \$150,000. Commissioner Ruvoli said he still favors a November, 2026 Referendum. Phased plans were discussed. Different amounts to ask for were discussed. Discussion of buying Roma, but there were so many conditions to it.
 - B. Fort Frankfort Update The *poured n' play* surface has been finished. Some pieces are still not delivered, and two deck pieces need the correct coating. The footings for the large wood structure were poured. Signage and proposed plaques were discussed.
 - C. Five Oaks Park The HOA has to draft the agreement and take it to their members to approve or deny. Gina has not heard anything back from the HOA.
 - D. DCEO Funding Tod from Design Perspectives was present to discuss his meetings with the affiliates groups. This is in the design process. Football, Boys' Baseball, Girls' Baseball and Soccer were in the meetings. He is educating them on the grant and is asking them for feedback on what their needs and wants are. They met yesterday and
